CONTEST RULES

Article 1: Contest Organization

Article 2: Contest Duration

Article 3: Participation Conditions

Participants must have an internet connection and a valid email address. Employees of the organizer and their immediate family members are not eligible to participate.

Article 4: Participation Methods

To participate, simply:

- 1. Visit the dedicated Contest page, accessible at www.own18.com.
- 2. Fill out the participation form with the required information (name, first name, email address, etc.).
- 3. Answer the two questions provided.

We then invite you to like the post or share the Contest post.

Only one entry per person is allowed. Any attempt at fraud will result in the immediate exclusion of the participant.

Article 5: Winner Selection

The winner will be chosen by a random draw from all valid entries. The draw will take place within 24 hours of the Contest's conclusion, under the supervision of the Director of NBG SRL, using the platform "commentpicker.com."

The winner will be contacted via email or phone within three days of the draw. If the winner does not respond within five days of receiving the notification, a new draw may be conducted.

Article 6: Prize

The prize consists of a one-week stay in a vacation house located on the north coast of Menorca. This fully equipped house can accommodate up to 6 people.

The stay must be chosen from the following available periods: between March 15, 2026, and May 1, 2026, or between November 1, 2025, and November 30, 2025.

The cleaning fee for the house (175 euros) will be charged separately. A security deposit will be required at check-in and refunded at check-out.
